Building Permit Requirements

Additional Residential Units

NOTE TO APPLICANTS: Please check with the Zoning Plans Examiner or Building Official to ensure the proposed residential addition meets the requirements of or is not affected by the following regulations or requirements prior to submitting an application for a building permit.

Zoning Review the zoning by-law with a plans examiner to confirm the use, size and setback regulations are met.

Conservation Authority If any part of the lot is within an area regulated by the conservation authority, a permit may be required. This may affect the building location and/or grading of the lot.

Building Permit Application

1. **Completed building permit application** consisting of:
 - Application form "Permit to Construct or Demolish"
 - Schedule 1: Designer Information
 - Site Plan Control Agreement
 - Septic permit from Northumberland County (if required)
 - Setback permit from Northumberland County (if required)
2. **One** copy of plans including (refer to our Additional Residential Unit Guide for assistance):
 - Site survey sketch showing location of proposed addition including dimensions and distance from property lines, septic tank/field and other buildings.
 - Plan(s) and cross section(s) drawings to include the following information:
 - i. **Floor plans**
 1. Overall dimensions and dimensions of each room
 2. Use of each room
 3. Size, type(material), location and spacing of all structural framework including beams, lintels, columns, joists, bearing walls and partitions
 4. Size and material of ceiling, wall, and floor assemblies
 5. Location of all plumbing fixtures
 - ii. **Elevation plans**
 1. Overall dimensions and dimensions of doors and windows
 2. Grade level
 3. Exterior wall cladding, finishes and flashing

iii. Cross section details

1. Floor construction, size of footing and foundation wall, and foundation drainage
2. Exterior and interior wall construction
3. Roof and ceiling construction (if pre-manufactured trusses/floors are used submit specifications and layout)
