## Deck

NOTE TO APPLICANTS: Please check with the Zoning Plans Examiner or Building Official to determine whether the proposed deck is permitted in accordance with the Township of Hamilton, Zoning By-Law, prior to submitting an application for a building permit.

### Building Permit Application

1. **Completed building permit application** consisting of:
  - Application form "Permit to Construct or Demolish"
  - Schedule 1: Designer Information
  - Site Plan Control Agreement
  - Setback permit from Northumberland County (if required)
  
2. **One** copy of plans including (refer to 'Deck Design Guide' for assistance):
  - Site Survey Sketch showing the location of the proposed deck including dimensions and distance from property line(s) and other buildings
  - Plan(s) and section drawings to include the following information:
    - i. Footing and foundation construction details including location, depth, size and spacing of piers
    - ii. Details of beams and joists including material, size, span, location and spacing
    - iii. Details showing height from finished grade and method of attachment to house
    - iv. Details of guard, stairs and handrail where applicable
  
3. **Permit Fee:**
  - Refer to Fees and Charges By-Law 2017-15 as amended.
