- Assist other services such as police, paramedics, public agencies, and the community as needed.
- Maintain firefighting and rescue equipment, as well as facilities.
- Stay current with professional standards and continuously enhance skills, knowledge, and physical fitness required for the role.

- Valid unrestricted Ontario Class G driver's license.
- Valid unrestricted Ontario Class D driver's license with a Z endorsement considered an asset.
- Ability to assess dynamic situations quickly and make sound decisions under pressure.
- Strong interpersonal skills with the ability to work effectively as part of a cohesive team in high-stress environments.
- Demonstrated capacity to remain calm, focused, and effective in challenging and emotionally charged situations.
